 you from the waiting room into the virtual court room.
- If you attend by phone, only your phone number (not your name) will appear in the Zoom waiting room. If you expect to attend via phone, please advise Court Services and the Crown in advance by email (at the addresses noted above). Please include the phone number from which you will be calling so that you may be identified, and your matters called at the appropriate time.
- Until further notice, any self-represented or unrepresented accused who does not attend remote remand court will be presumptively adjourned 5 weeks.
